## The Future of Shooting

I'd like to express my appreciation to the newly appointed team of instructors who have stepped in to help get the club's Junior Rifle season off the ground in 2025. It's great to see 17 kids learning about safe firearms handling and the basics of rifle shooting as beginners this year, with another 10 returning for another year to work their way up the NRA Marksmanship Qualification ladder.

In another first (as far as I know) for the program, we have Apprentice Instructors assisting. I'm excited to see our young people get interested in the shooting sports and in learning how to teach others so they can keep passing it on. Becoming an Apprentice Instructor gives teens more leadership experience that can help as they navigate school, sports, and other activities in life. For that,

I appreciate our Education Committee's dedication to finding Training Counselors who support young instructors and help them flourish.

I give sincere thanks to those who have lead the Junior Rifle program through the years. In fact, we just stumbled across the 1990 board records and newsletters that show when the Junior Rifle program's first iteration of the current program was proposed and approved.

This is also the time of year that anyone who is a 5+ year or life member of the NRA gets a say in the future of that organization. We ended our 64-year long affiliation and 100% requirement in 2022, but most of our members understand that no other pro-gun group has managed to step in to fill *all* of the gigantic shoes of the organization across

training, lobbying, legal work, election efforts, and the shooting sports. (Don't worry, the 100% requirement isn't coming back. That ship sailed.)

Some groups have managed some good work on the legal front, but without the lobbying and election networks to address laws before we have to go to court. Other groups have been very successful as sanctioning bodies for one single sport, but none have the breadth that NRA once had.

Ideally, the future includes a healthier NRA, alongside the robust ecosystem of other specialized gun rights groups and shooting sports organizations. Inside, you'll find a piece by one of the reform-focused candidates - and a list of some others he's running with - to help make that reality happen.

# Board Briefs

*A Summary of What Your FTRPA Board is Doing*

## December

- Dissolved the little used indoor & outdoor range committees, with the tasks of scheduling & match approval returning to the Board following the November bylaw results;
- Updated range rules, including calibers permitted on the indoor range and nighttime archery policies;
- Passed resolution authorizing corporate purchase of revolvers for use in basic pistol and range safety officer courses offered by the Education Committee;
- Declined request to expand 50 & 100/200 yard range closures for NRL22 throughout the year, but did agree to a one-time approval for a longer range use in December 2024;
- Followed up on a formal approval of previously agreed upon women's shoot date for January;
- Restructured youth shooting education programs to be a subcommittee under the larger Education Committee, accepted resignation of some junior rifle leaders and president announced new appointments to support those who chose to continue helping, then Board approved dates for January to March 2025;
- Approved September dates for a Rangemaster Combative Pistol course in final stages of confirmation;
- Reviewed & approved changes to phone & internet services that will result in faster internet, more remote access services, and save the club more than \$1,100 annually; and
- Approved budget to engage engineers for initial study and work on range wall work for the 200-yard range.

- Reviewed email vote approving purchase of two CMP-sold left-handed Savage single shot rifles for Junior Rifle;
- Voted to fill the trustee vacancy created when Dan Buckley elevated to Secretary with Kevin Neidel;
- Approved a date to host a club flea market in Summer 2025;
- Approved a September date for use of meeting room for a Two Pillars Training lecture; and
- Approved applying for a small games of chance license to allow the club and its programs to consider raffle and 50/50 drawings for fundraising.

## Guest Policies

If you bring a guest to shoot a match and arrive early or stay late, you need to pay a guest fee if they are going to participate in shooting or fishing activities before or after the match.

Guest fees are only waived for the duration of matches (matches may charge non-member rates) and their participation in that specific event, not hours before or after.

A guest who sticks around with you while you take a few shots after a match just needs to be signed in as "not shooting or fishing" and badged. However, they cannot shoot or fish if you sign them in that way.

As a reminder, we offer more ways to pay guest fees than ever: cash, Zelle, check, or Venmo. It's much better to pay up front than get fined. The fine is \$30, plus the guest fees that weren't paid, for a first offense. After that, it goes up and risks a Board hearing.

## NRA CCW - February 23

FTRPA is hosting NRA CCW led by members on February 23 from 8:30am to ~5:30pm. The course teaches the knowledge, skills, & attitude necessary to safely carry concealed for personal defense.

The cost for club members is \$125 and for non-members is \$175. Participants will need to bring their own handgun, ammunition, and equipment requested by the instructors for this course. [Register here.](#)

## NRA Basic Pistol Student Class April 6

Want to refresh your pistol-handling skills or get a commonly required basic safety class required for additional training? The NRA Basics of Pistol Shooting has you covered.

Course topics include: gun safety rules, operation of revolvers and semi-automatic pistols, ammunition knowledge, pistol selection, shooting fundamentals, maintenance, marksmanship, and shooting range safety. Additionally, students complete live fire training and pass a nationally standardized shooting qualification.

pig they missed in a single match was the determining factor in their long run records.

In recognition of great shooting, Club President Keith Milligan presented Jenna with a new prize for the contest: El Presidente Asesino de Javelina Prize.

# Becoming an Instructor

Training for various intermediate and advanced credentials in the firearms world can require different standards, and I hope to continue breaking some of those down for members so you feel encouraged to take up the training opportunities that you might have been tempted to try.

In this issue, I'll discuss NRA instructor training. This is one of the most popular courses to take for earning instructor credentials since it comes with a nationwide network that promotes NRA training.

To be a full Certified Instructor, you'll need to be at least 21 and take a series of classes explained below. Mature young people aged 13 to 21 may take the courses and qualify as either Assistant or Apprentice Instructors so they can assist full instructors with classes and get hands on training that will help build leadership skills. At age 21, they can convert to full instructors.

Generally speaking, there are three classes ultimately needed to become an NRA instructor:

- » Basic Instructor Training (BIT);
- » Student version of the class you'd like to teach; and
- » Instructor discipline version of the class you'd like to teach.

*The first two of those courses can be taken in any order.* Only the third class topic requires both of the previous courses.

The student course of any topic can be from any time. If you took

a student-level class for the vast majority of NRA training subjects before April of 2017, then you likely received a paper certificate for your class. You may present that - a photo is fine - for proof. If you took a class after that date, your instructor likely opted for the PDF digital certificate which you can share as proof of the course when becoming an instructor.

BIT alone does not qualify someone as an NRA instructor. It is simply one half of the instructor-level program.

However, it is valid for two years. That means you can take as many instructor discipline courses in that two years. You do *not* have to take

BIT every single time you pick up a new discipline course.

Currently, keeping current with BIT is a largely honor system situation. However, we are trying to track last BIT dates for those who take the classes at FTRPA until the NRA launches their tracking tool for that class. Based on the Education & Training Department's update to NRA members at their annual meeting, this feature of internal NRA tracking may launch in the next year or two.

Different Training Counselors have different policies when it comes to teaching BIT. Some may charge for every single time you need to refresh BIT. Others, including those we have been hosting at FTRPA to lead the class, offer low cost (or sometimes free) refresher BIT courses once you have taken one paid course with them.



## **NRA Basic Pistol Class** **Instructor - May 31**

This one day course teaches the knowledge, skills and attitude essential to organizing, promoting and teaching NRA's popular Basics of Pistol Shooting course. In order to take this class, you need to have taken the NRA Basic Pistol student course at any point in advance *and* NRA Basic Instructor Training (BIT) within the previous two years.

Pre-registration is required and can be [found at this link](#) or on the member-only website. The ~8 hour class (with lunch break) begins at 8:00am and costs \$150.

# Nicholas Johnson's New Role

In December, the University of Wyoming College of Law's Firearms Research Center announced that former a FTRPA member, Professor Nicholas J. Johnson at the Fordham University School of Law, has become a Fellow with their Research Center.

Prof. Johnson teaches in the areas of gun control, gun rights, contracts, and environmental law. He is a 1984 graduate of Harvard Law School. In addition to writing *Negroes and the Gun*, he is a co-author of *Firearms Law and the Second Amendment: Regulation, Rights and Policy*.

He contributes to the media, including the *New York Times*, *Washington Post*, *Wall Street Journal*, *National Review*, Library of Law and Liberty, BBC News, ABC News, & MSNBC. Johnson has testified before Congress on firearms law and his work on firearms law has been cited by the Supreme Court.
